## Central Ministries and Parish Support

The 50 plus ministries housed at the Pastoral Center in Braintree play a critical role in carrying out the Church's mission across the Archdiocese. These ministries further the work of the church through the many institutions and millions of Catholics that comprise the Archdiocese.

Central Ministries provides programs and services that include:

- Programs to hand on the faith to the young and new Catholics
- Support for the formation of priests, deacons, and lay leaders
- Resources for Cardinal Seán as he serves and guides our local church

# IFRM MODIFICATIONS DECREE – new model structure

• **Remove** Net Rental Income from base revenue for both Central Ministry Tithe and Catholic Appeal Assessment calculations.

Base Revenue = 3 Year Average of Offertory + Offertory Monthly + Grand Annual

- Central Ministry Tithe calculated as 10% of Base Revenue
- Catholic Appeal Assessment calculated as 8% of Base Revenue
- Net Rental Income would be taxed as a separate line item on the monthly billing at the current 18%
- Implement a tax on the Net Proceeds from the Sale of Property at 18%
- Create a "Pooled" Catholic Appeal rebate structure

-To qualify for a Catholic Appeal rebate or abatement (Central Ministry Tithe & Catholic Appeal), parishes would need to;

• Meet or exceed their in-pew goal

• Engage a Catholic Appeal Coordinator

# IFRM MODIFICATIONS DECREE

- -A "pool" of funds would be created for parishes that meet the conditions above and exceed their Catholic Appeal Assessment.
  - The Tithe and Catholic Appeal abatements would be paid from the pool
  - Balance of funds would be distributed as rebates on a prorated basis
  - Rebate distribution would change from 3 times per year to 2 a year (August/February)
- Review IFRM every five years
